Assumption of Risk

I acknowledge and agree that any use of Fremont Family YMCA facilities, services, equipment, and premises ("Facilities") and any participation in Fremont Family YMCA programs and activities ("Programs") comes with inherent risks including, but in no way limited to: (1) moderate and severe personal injury, (2) property damage, (3) disability, (4) death, and (5) sickness or disease including, without limitation, COVID-19. I voluntarily accept and assume full responsibility for these risks as well as any and all other risks of the use of the facilities and participation in programs. I agree that I have full knowledge of the nature and extent of all such risks and am not relying on all such risks being described in this document.

Waiver, Release, Indemnification, and Covenant Not To Sue

In consideration of the use of Facilities and participation in Programs, I, the undersigned, agree that the Fremont Family YMCA, its officers, directors, agents, employees, volunteers, insurers, and representatives ("Releasees") will not be liable for any personal injury, property damage, disability, death, sickness, or disease incurred by myself, my family members, dependents, or guests, including minors, however occurring, including but not limited to the negligence of Releasees. I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, disability, death, sickness, or disease sustained from the Facilities and participation in Programs.

I further agree, on behalf of myself and any and all legal successors and proxies, to release and HEREBY DO RELEASE, WAIVE AND COVENANT NOT TO SUE Releasees from any causes of action, claims, suits, liabilities, or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which I and any and all legal successors and proxies may have, now or in the future, against Releasees on account of personal injury, property damage, disability, death, sickness, diseases, or accidents of any kind, arising out of or in any way related to the use of Facilities or Participation in programs, whether that participation is supervised or unsupervised, however the injury or damage occurs, including but not limited to the negligence of Releasees. In further consideration of the use of Facilities and participation in Programs, I agree to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, suits, liabilities, and costs of any nature whatsoever, including claims of negligence, arising out of or in any way related to the use of Facilities and participation in Programs by myself, my family members, dependents, or guests, including any minors.

Fremont Family YMCA Member Code of Conduct

The Fremont Family YMCA is committed to providing a safe and welcoming environment for all members and guests. To promote safety and comfort for all, we expect individuals using our facility act in a mature and responsible way at all times and to respect the rights and dignity of others while in the facility or when participating in our programs.

Our code of conduct does not permit language or any action that may hurt or frighten another person or that generally falls below a generally accepted standard of behavior.

As a member, participant, or guest, you agree to follow this code of conduct and the YMCA core values of caring, honesty, respect, and responsibility.

- 1. Appropriate attire must be worn at all times. Clothing with vulgar language, obscene gestures, racial slurs, or that contributes to a hostile environment is not allowed.
- 2. Refrain at all times from using angry or vulgar language to include swearing, name calling, or shouting.
- 3. Threatening physical contact of any kind is not allowed.
- 4. Any inappropriate conduct of a sexual nature is not acceptable.
- 5. Harassment or intimidation by words, gestures, body language toward another person is not permissible.
- 6. Theft or behavior that results in destruction of YMCA or member/guest property is not allowed.
- 7. The YMCA bans any and all kinds of weapons with or without a permit.
- 8. Drugs and alcohol are not acceptable on any YMCA premises.
- 9. Any cell phone activity is not permitted in locker rooms, fitness areas, or pool areas.
- 10. Bluetooth personal speakers are not permitted in the YMCA.
- 11. Tobacco use of any kind is not permissible on YMCA premises or programs to include cigarettes, chewing tobacco, vapor, or e-cigarettes.

If the guidelines listed above are not followed, action will be taken. Actions may include suspension, temporary or permanent, of YMCA member/guest privileges based on the nature and number of offenses. This is subject to the discretion of the YMCA staff team.
